The Annual Meeting of Shareholders of 2020 would be held at 2F, No. 6, Wulin Street, Sulin District, New Taipei City, Taiwan (Service Center, Sulin Industrial Park, Industrial Development Bureau, Ministry of Economic Affairs) at 9 A.M. on May 28, 2020. - II. The Company's report on 2019 cash dividend payout is proposed and resolved by the Board of Directors as follows
  - 1. The Company plans to distribute cash dividends at the amount of NT\$84,394,601, that is, NT\$2.15 per share. Cash dividends are distributed according to the shares held in the shareholder registry on the record date. Cash dividends are rounded up to dollar. The Chairman is authorized to determine the disposal of less than NT\$1 at his discretion.
  - 2. When there is any change in the Company's outstanding shares; the Chairman is authorized to adjust the dividend per share in accordance with the actual outstanding shares on the ex-dividend date.

  Candidates' list: (1) Four seats for directors: TANG, SHIH-CHUAN, HUNG, CHIA-CHENG, CHEN, MING-HSIN and HSIAO, CHEN-CHI. (2) Three seats for independent directors: HSU, CHUNG-YUAN, CHOU, LIANG-CHENG and LEE, SHYH-CHIN.

- V. The shares transfer is postponed from March 30, 2020 to May 28, 2020 based on the regulations of Article 165 of the Company Act.
